As such, the Board proposes to amend the M&A for the purposes of, among others, (i) conform to the said core standards for shareholders' protections; (ii) allow a general meeting to be held as electronic meeting (also referred to as virtual general meeting) or a hybrid meeting, (iii) bring the articles of association of the Company in line with amendments made to Appendix 3 to the Listing Rules and applicable laws in the Cayman Islands; and (iv) incorporate certain housekeeping amendments to the M&A for the purpose of clarifying existing practice and make consequential amendments in line with the amendments to the M&A (collectively, the "Amendments"). Details of the proposed Amendments will be set out in the circular to be despatched to the shareholders of the Company (the "Shareholders") in due course.

At the forthcoming annual general meeting of the Company (the "2023 AGM"), a special resolution as special business will be proposed for the Shareholders to consider and, if thought fit, approve the proposed adoption of the second amended and restated memorandum and articles of association (the "New Memorandum and Articles of Association") incorporating the Amendments.

A circular containing, among other things, detailed information of the proposed Amendments as well as the adoption of the New Memorandum and Articles of Association and a notice of the 2023 AGM will be despatched to the Shareholders in due course.
