Chairman's Statement 主席報告

Dear Shareholders:

On behalf of the board of directors (the "Board") and the management of Great World Company Holdings Ltd (the "Company", together with its subsidiaries collectively referred to as the "Group"), I am pleased to present to you the annual report of the Group of the year ended 31 March 2023.

On the one hand, the economic outlook as a whole remains weak. The ongoing trade disputes, political uncertainties and global pandemic have all had a considerable impact on our business operations.

The Group recorded a total turnover of approximately HK\$162,530,000 for the year ended 31 March 2023, representing a decrease by approximately 49.8% as compared to approximately HK\$323,634,000 of last year. Loss attributable to owners of the Company for the year was approximately HK\$58,164,000 (2022: HK\$41,082,000), representing an increase by approximately 41.6%. The Board did not propose any dividend for the year (2022: Nil).

However, despite these challenges, the Group has continued to seek new opportunities and adapt to the changing economic landscape. We are still pursuing new markets, implementing cost-saving measures and looking for investment opportunities in innovative technologies to remain competitive. We will leverage our established supply chain network as well as our media resources to expand into promising market segments such as international vehicle trading focusing on emerging markets and domestic cultural and tourism products.

While the future remains uncertain, we are confident that we can continue to thrive in the coming years. We are constantly exploring new avenues of growth and diversification and we remain committed to delivering value to our shareholders.

本人代表世大控股有限公司(「本公司」, 連同其附屬公司統稱「本集團」)董事會 (「董事會」)及管理層,欣然向 閣下呈 列本集團截至二零二三年三月三十一日 止年度之年度報告。

一方面,整體經濟前景依然疲弱。持續 的貿易糾紛、政治不明朗因素及全球疫 情均對我們的業務營運造成重大影響。

截至二零二三年三月三十一日止年度, 本集團錄得總營業額約162,530,000港 元,較去年的約323,634,000港元減少 約49.8%。年內本公司擁有人應佔虧 損為約58,164,000港元(二零二二年: 41,082,000港元),增加約41.6%。董事 會並不建議於年內派付任何股息(二零 二二年:無)。

然而,儘管面臨該等挑戰,本集團仍繼 續尋求新機遇,適應不斷變化的經濟環 境。我們仍在開拓新市場,實施節省成 本的措施,並在創新技術方面尋找投資 機會,保持競爭力。我們將利用成熟的 供應鏈網絡及媒體資源,擴展至前景廣 闊的細分市場,如專注於新興市場的國 際汽車貿易及國內文旅產品。

儘管未來仍不明朗,但我們有信心在未 來數年繼續蓬勃發展。我們不斷探索新 的增長和多元化途徑,並致力於為股東 締造價值。

MARKET REVIEW

Intelligent Advertising and Railroad Media Business

Intelligent Advertising Business The year 2023 marks a significant milestone for the digital advertising market in China. With the increasing penetration of the internet and smartphones, the Chinese market has become the largest digital advertising market in the world. According to a report by dentsu China, digital media is projected to account for 80% of total local advertising spending in China by 2024. This trend is expected to continue in 2023, with digital advertising spending projected to reach US\$173.6 billion.

Precise marketing has become increasingly important in reshaping the rules of content seeding in China's digital advertising market. Brands are using precise marketing to target specific audiences, using technologies such as AI and big data to analyze consumer behavior and preferences. The use of KOLs (Key Opinion Leaders) has also become a popular way for brands to connect with their target audience and increase brand awareness.

OTT (Over-The-Top) activation terminals are concentrated in second, third, and fourth tier cities in China. The penetration of OTT platforms, such as iQiyi and Tencent Video, has been significant in these areas due to the lack of traditional media infrastructure. As a result, advertisers are investing more in these platforms to reach audiences in these cities.

Railroad Media Business

China's domestic tourism market has shown signs of recovery, with domestic travel volume having recovered to 90% of pre-pandemic levels in the first quarter of 2023, approximately 1.2 billion domestic tourist trips were made in China. The top three international travel destinations for Chinese tourists are Australia/New Zealand, Southeast Asia and Japan. However, fear of COVID-19 and expensive COVID-19 testing, among other factors, may deter travelers from taking to the skies.

市場回顧 智能廣告及鐵路媒體業務 - 智能廣告業務

二零二三年標志著中國數字廣告市 場的一個重要里程碑。隨著互聯網 及智能手機的大量普及,中國市場 已成為全球最大的數字廣告市場。 根據電通中國的一份報告,預計到 二零二四年,數字媒體將佔中國本 地廣告總支出的80%。這一趨勢預 計將在二零二三年持續,數字廣告 支出預計將達到1,736億美元。

精準營銷在重塑中國數字廣告市場 內容播種規則方面變得愈發重要。 品牌正在使用精確營銷來鎖定特定 受眾,使用人工智能和大數據等技 術來分析消費者行為和偏好。使用 KOL(關鍵意見領袖)也成為品牌與 目標受眾聯繫和提高品牌知名度的 一種流行方式。

OTT (Over-The-Top)激活終端集中在 中國的二、三、四線城市。由於缺 乏傳統媒體基礎設施,愛奇藝和騰 訊視頻等OTT平台在這些領域的滲透 率很高。因此,廣告商正在這些平 台上投入更多資金,以觸達這些城 市的受眾。

- 鐵路媒體業務

中國國內旅遊市場已呈現復甦跡 象,二零二三年第一季度國內旅遊 量已恢復至疫情前水平的90%,中 國國內旅遊人次約為12億人次。 中國遊客的前三大國際旅遊目的地 是澳大利亞/新西蘭、東南亞和日 本。然而,對COVID-19的憂慮和昂 貴的COVID-19檢測等其他因素,可 能會對遊客跨境旅遊造成影響。

Despite these challenges, the domestic tourism market in China is projected to continue growing. Fitch believes that the tourism sector is less affected by uncertainty over employment and income growth than other service and retail sectors. To stay ahead of the competition, brands should provide unique and personalized experiences that cater to the changing needs and preferences of Chinese tourists. Key trends in the market include short-distance and self-driving travel as well as rural and nature-based tourism.

Overall, the post-COVID domestic tourism market in China presents significant growth potential for brands that can adapt to changing market trends and provide exceptional experiences for travelers. With the right strategies in place, businesses could drive growth and tap into the thriving domestic tourism market in China.

Agricultural, Forestry and Consumer Products Business

Chinese agricultural producers face various challenges and difficulties in 2023. While China aims to be more self-sufficient in food production, they continue to struggle to increase their production to meet the growing demand. This is due to problems such as farmland loss, degradation, acidification and salinization, which have been escalating in recent years. Additionally, the country's agriculture industry faces challenges with imports and competition from other countries, which can limit their growth. The government has made preserving farmland and ensuring domestic supply key priorities, but this requires significant investment and resources. Therefore, Chinese agricultural producers must navigate these challenges to ensure the sustainability and growth of their industry.

Supply-chain Business

In 2023, the supply chain industry is facing a range of challenges, including ongoing trade tensions, pandemic-related disruptions, and a shortage of factory workers. Despite these issues, China remains a dominant player in the technology and electronics industry. US companies are diversifying their sourcing options to countries such as India, Mexico and Vietnam, while the Chinese government is taking steps to ensure domestic supply.

儘管面臨這些挑戰,中國國內旅遊 市場預計將繼續增長。惠譽認為, 與其他服務和零售行業相比,旅遊 愛就業和收入增長不確定性的影響較小。為了在競爭中保持領先地 的體驗,以迎合中國遊客不斷變化的 需求和偏好。市場的主要趨勢包括 短途和自駕旅遊以及鄉村和自然旅 遊。

總體而言,後疫情時代的中國國內 旅遊市場展現強大的增長潛力,為 能夠適應不斷變化的市場趨勢、給 遊客提供卓越體驗的品牌提供了機 會。企業制定正確的策略方可推動 增長,並進軍迅猛發展的中國國內 旅遊市場。

農林產品及消費品業務

供應鏈業務

二零二三年,供應鏈行業面臨一系列挑 戰,包括持續的貿易緊張局勢、疫情相 關的中斷和工廠工人短缺。儘管存在這 些問題,中國仍然是科技和電子行業的 主導者。美國企業正在將其採購選擇多 樣化,轉向印度、墨西哥、越南等國, 而中國政府正在採取措施確保國內供應。

Businesses that rely heavily on Chinese manufacturing should take action to mitigate risks to their supply chains, such as building stronger relationships with suppliers and investing in technology to improve supply chain visibility and resilience. The industry is characterized by increased competition, rising costs and a heightened focus on risk management.

In recent developments, the JPMorgan Global Manufacturing Purchasing Managers' Index reported that global manufacturing output increased in February 2023, following a six-month period of decline caused by the COVID-19 pandemic. Supply chain problems also eased, aiding production in mainland China.

Overall, the supply chain industry in 2023 is characterized by a range of challenges and opportunities, with China remaining a major player in the technology and electronics industry. Businesses must take steps to mitigate risks and improve supply chain resilience to remain competitive in this environment.

Property Business

In 2023, China's property market continues to face challenges despite early signs of recovery. The research firm China Beige Book reported a sharp decline in both pricing and transactions in the commercial property space, while Moody's estimates that the property sector and its related industries account for over 25% of China's economy. Despite this, the National Bureau of Statistics' home price index, based on 70 cities, rose month-on-month, indicating stabilizing home prices in 2023. Standard & Poor's expects China developer sales to fall by about 3% to 5% in 2023, slightly better than the previously forecasted 5% to 8% drop. In summary, China's property market remains fragile in 2023, and policymakers may need to take action to support the industry's recovery.

嚴重依賴中國製造業的企業應該採取行 動降低供應鏈的風險,比如與供應商建 立更牢固的關係,投資技術以提高供應 鏈的可見性和彈性。科技電子行業的特 點是競爭激烈、成本高企和對風險管理 的高度重視。

近期發展中,摩根大通全球製造業採購 經理人指數報告稱,因COVID-19疫情, 全球製造業產出連續六個月下降,而後 於二零二三年二月有所增加。供應鏈問 題亦有所緩解,有助中國內地的生產。

整體而言,二零二三年供應鏈行業的特點是挑戰機遇併存,中國仍是科技和電子行業的主要參與者。企業必須採取措施降低風險,提高供應鏈彈性,才能在這種環境下保持競爭力。

物業業務

二零二三年,中國物業市場雖有初步復 甦跡象,但仍面臨挑戰。研究公司中國 褐皮書報告稱,商業物業領域的定價和 交易都大幅下降,而穆迪估計,物業行 業及其相關行業佔中國經濟的25%以 上。儘管如此,國家統計局基於70個城 市的房價指數環比上漲,指出二零二三 年,一國開發商銷售額將下降約3% 至5%,略好於此前預測的5%至8%的降 幅。綜上所述,二零二三年中國物業市 場依然脆弱,政策制定者可能需要採取 行動支持行業復蘇。

BUSINESS REVIEW

Intelligent Advertising and Railroad Media Business

– Intelligent Advertising Business

Shenzhen Zhixunpai Information Technology Company Ltd., a subsidiary of the Company, has maintained a leading position in the industry thanks to its intelligent advertising and media services, despite uncertainties in the real estate sector. With the current challenges faced by the China real estate market, most players are experiencing cashflow difficulties and significant reductions in their advertising budgets.

Given the prevailing market sentiment due to the impact of COVID-19 and sector-specific challenges, we are focused on diversifying the applications of our proprietary Big Data and AI technological platforms to explore new growth opportunities. Our AI system's powerful data processing capabilities enable it to be adapted to a wide range of applications that we will carefully investigate. These include applying the analytic capabilities in investment decisionmaking and providing AI-driven digital marketing strategies in our other business segments. With our rich digital media background, we will also explore applications and opportunities in short video and social media industry.

Developing such verticals will create additional growth opportunities and broaden our income sources while fostering additional synergies between our various businesses.

Railroad Media Business

Since we started providing railroad media services in 2019, the Group has garnered extensive expertise and access to high-speed railroad resources while expanding organically within the ecosystem. However, the COVID-19 pandemic caused significant disruption to the travel and tourism industries, which hindered the high-speed railroad media's anticipated growth potential.

Nonetheless, the development of vaccines and the low mortality rate of recent variants have led to gradually opening borders and resuming travel worldwide. This presents an opportune time for the Group to expand its business into the recovering travel sector and potentially benefit from post-pandemic explosive growth. As a result, the Group is actively seeking suitable investment opportunities in related sectors and is taking steps to tap into cultural tourism resources and develop rural characteristic tourism products.

業務回顧 智能廣告及鐵路媒體業務 *一 智能廣告業務*

本公司附屬公司深圳智訊派信息科 技有限公司在房地產行業不明朗的 情況下,憑藉其智能廣告和媒體服 務,依然保持行業領先地位。有鑒 目前中國房地產市場面臨的挑戰, 大部分企業正面臨現金流困難,並 且大幅削減廣告預算。

該等垂直領域的發展將帶來額外的 增長機會並拓寬收入來源,同時在 我們各業務之間培養額外的協同效 應。

鐵路媒體業務

自我們於二零一九年開始提供鐵路 媒體服務以來,本集團已積累了廣 泛的專業知識和高速鐵路資源,同 時在生態系統內進行有機擴張。然 而,COVID-19疫情對旅行和旅遊業 造成了重大干擾,阻礙了高速鐵路 媒體的預期增長潛力。

儘管如此,由於疫苗的發展和最近 變種的低死亡率,邊境逐步開放, 全球旅行慢慢恢復。旅遊業正在復 甦,而本集團將把握時機,將其業 務擴展至該行業,並有可能從疫情 後爆炸性增長獲益。因此,本集團 積極在相關行業尋找合適的投資 備 會,並採取措施挖掘文旅資源,開 發鄉村特色旅遊產品。

For the year ended 31 March 2023, revenue generated from the provision of intelligent advertising and railroad media services was approximately HK\$142,228,000 (2022: HK\$299,784,000).

Agricultural, Forestry and Consumer Products Business Demand for our agricultural and forestry products are decreasing due to sluggish consumer demand in an economic downturn.

The Group is exploring potential investment opportunities in Chinese medicine sector especially Chinese medicine processing which would enable tapping into mass market consumption and provide additional growth potential.

For the year ended 31 March 2023, revenue generated from the sales of agricultural, forestry and consumer products was approximately HK\$18,316,000 (2022: HK\$22,507,000).

Supply-chain Business

With unfavorable market condition and a global lack of appetite for Chinese manufacturing, the Group is closely observing industries of interest to seize potential investment opportunities in order to diversify its product portfolio further and broaden the income sources.

The Group has been successful in establishing international trading lines for their car trading business and is now looking to expand this venture further. The Group's efforts in building its global network have paid off, as they have been able to develop partnerships with suppliers and distributors across multiple regions. This expansion has allowed the Group to improve its supply chain management, enabling them to provide high-quality cars to customers worldwide, especially in emerging markets. With their sights set on even greater success, the Group is determined to continue growing this business down the line.

For the year ended 31 March 2023, revenue generated from the sales of supply-chain products was approximately HK\$846,000 (2022: HK\$4,000).

截至二零二三年三月三十一日止年度, 提供智能廣告及鐵路媒體服務產生的收 入約為142,228,000港元(二零二二年: 299,784,000港元)。

農林產品及消費品業務

由於經濟低迷時期消費者需求低迷,對 我們農林產品的需求正在下降。

本集團正發掘中醫中藥行業的潛在投資 機會,特別是中藥加工,以開拓大眾市 場消費,並提供額外的增長潛力。

截至二零二三年三月三十一日止年 度,銷售農林產品及消費品產生的收 入約為18,316,000港元(二零二二年: 22,507,000港元)。

供應鏈業務

在市場條件不利及全球對中國製造需求 疲弱的背景下,本集團密切關注感興趣 的行業,把握潛在投資機會,進一步豐 富產品組合,拓寬收入來源。

本集團已成功為其汽車貿易業務建立國 際貿易渠道,目前正尋求進一步擴大投 資項目。隨著與多個地區的供應商和經 銷商建立合作夥伴關係,本集團建立全 球網絡的努力取得了成效。合作關係的 擴展使本集團得以改善其供應鏈管理, 使其能夠向全球客戶提供高質量的汽 車,尤其是在新興市場。本集團以取得 更大成功為目標,決心繼續發展此業務。

截至二零二三年三月三十一日止年度, 供應鏈產品銷售產生的收入約為846,000 港元(二零二二年:4,000港元)。

Property Business

The Group owns a property which comprises a residential and commercial development site with a site area of approximately 3,111.96 square meters ("sq.m.") located at Leshan City, Sichuan Province, the People's Republic of China. The property has a gross floor area of approximately 27,134.46 sq.m. (inclusive of a basement floor) and comprises 4 types of functions, namely residential, commercial, basement car park and facilities.

Due to unfavorable market conditions, the property's value has dropped, and the Group is now looking for a way to sell it as soon as the market conditions recover to a better level. The Group is constantly monitoring the market and exploring new opportunities to sell the property. The Group's experience in the real estate market gives us an advantage in navigating challenging times, and we remain optimistic about the future of this property.

For the year ended 31 March 2023, revenue derived from short-term leasing of the commercial portion of the property was approximately HK\$1,140,000 (2022: HK\$1,339,000).

OUTLOOK

The economic outlook for 2023 is mixed, with global economic growth expected to be negatively impacted by international tensions and the ongoing Ukraine war. However, China's commitment to economic reforms and focus on innovation and technology offer hope for growth. The government has implemented policies to support small and medium-sized enterprises and improve the business environment, which could boost investment and productivity.

The Group's profitability and business growth are affected by the current macroeconomic conditions.

The Group will seek to broaden the application of its Al technology platform as well as its high-speed railroad media resources to develop new lines of business focused on the strong recovery of China domestic tourism. The Group is also exploring investment opportunities in promising Chinese medicine products to break into the mass market consumption market and leverage its strong precise marketing and intelligent advertising capabilities.

物業業務

本集團擁有一棟位於中華人民共和國四 川省樂山市的物業,該物業包括一個地 盤面積約3,111.96平方米(「平方米」)的 住宅及商業開發地盤。該物業的總建築 面積約為27,134.46平方米(包括地下一 層),包括住宅、商業、地下停車場和設 施4類功能。

由於市況不利,該物業的價值下跌,本 集團現正尋求出售該物業的方法,以於 市況恢復至較佳水平後儘快出售。本集 團持續監察市場並發掘出售該物業的新 機會。本集團在房地產市場具備豐富經 驗,在這個充滿挑戰的時代使我們具有 一定優勢,因此我們對該物業的未來前 景保持樂觀。

截至二零二三年三月三十一日止年度, 該物業商業部分的短期租賃產生的收入約為1,140,000港元(二零二二年: 1,339,000港元)。

展望

預計全球經濟增長將受到國際緊張局勢 和持續烏克蘭戰爭的負面影響,二零 二三年的經濟前景複雜多變。然而,中 國承諾經濟改革,關注創新和技術,為 增長帶來了希望。政府實施了支持中小 企業和改善營商環境的政策,促進投資 和生產力。

本集團的盈利能力和業務增長受到當前 宏觀經濟狀況的影響。

本集團將尋求擴大其人工智能技術平台 及高鐵媒體資源的應用,以發展新的業 務線,將重心放在中國國內旅遊業的強 勁復蘇。本集團亦正在物色具前景的中 醫產品的投資機會,以打入大眾消費市 場,並發揮其強大的精準營銷及智能廣 告能力。

As supply-chain is being disrupted around the world, the Group is actively looking for stable and high demand products and will steadily grow the car trading business that shows promising growth potential.

The Group will remain conservative and prudent towards its profitability in the coming months. Nevertheless, we have taken measures to mitigate the impact of an economic downturn and will formulate necessary strategies and take further actions to enhance the long-term profitability and sustainability of the Group.

RISK FACTORS

Market Risk

Market risk factors for 2023 are heavily influenced by the ongoing geopolitical tensions, particularly the escalating conflict in Ukraine, which threatens to disrupt global supply chains and increase the cost of commodities. Additionally, rising inflationary pressures and the potential for central banks to raise interest rates could lead to a slowdown in economic growth. However, the increasing focus on innovation and technology, particularly in China, presents opportunities for growth and investment. In this uncertain environment, it is crucial for businesses to remain agile and adaptable to navigate the potential risks and take advantage of emerging opportunities.

Natural Risk

The occurrence of severe weather conditions, e.g. floods, droughts, cyclones and windstorms, and natural disasters, e.g. earthquakes, fire, disease, insect infestation and pests, may diminish the supply of plants available for harvesting, or otherwise impede the logging operations or the growth of plants, which in turn may have an adverse effect on the Group's agricultural and forestry products business. 由於全球供應鏈受到干擾,本集團正積 極尋找穩定及高需求的產品,並將穩步 發展具良好增長潛力的汽車貿易業務。

本集團將在未來數月保持對盈利能力的 保守和審慎態度。儘管如此,我們已採 取措施減輕經濟下行的影響,並將制定 必要的策略並採取進一步行動,以提高 本集團的長期盈利能力和可持續發展能 力。

風險因素 市場風險

二零二三年的市場風險因素受到持續地 緣政治緊張局勢的嚴重影響,特別是烏 克蘭不斷升級的衝突,這可能會擾亂全 球供應鏈並增加大宗商品的成本。 外,不斷上升的通脹壓力和中央銀行加 息的可能性可能導致經濟增長放緩。然 而,對創新和技術的日益關注,尤其是 在中國,帶來了增長和投資機會。環境 要的是:保持敏鋭,適應環境,以應對 潛在風險和把握新出現的機會。

自然風險

洪水、乾旱、氣旋和風暴等惡劣天氣條 件的發生,以及地震、火災、疾病、蟲 害和害蟲等自然災害,可能會減少可供 採伐的植物供應,或在其他方面阻礙伐 木作業或植物生長,進而可能對本集團 的農林產品業務產生不利影響。

Compliance with Laws and Regulations

Many aspects of the Group's business are subject to laws and regulations, including without limitation, sale of goods and services, trade descriptions, intellectual property, product safety, food safety, data privacy, insurance, dutiable commodities, product eco-responsibility, telecommunications and broadcasting, competition, listing and disclosure, and corporate governance, of China and other countries in the world. Whilst we manage compliance proactively and procure to obtain first-rate independent legal services to ensure the highest standards in compliance, any failure to comply with laws and regulations may result in legal proceedings and expose to liability and sanctions. In any event, dealing with complaints, investigations or legal proceedings, regardless of their outcome, could be costly and time-consuming and could divert management attention. More importantly, the long-term sustainability of our business is largely dependent on a steady and balanced regulatory environment. Unanticipated changes in policies or regulatory practices by the relevant authorities may require us to change our business strategies and practices, and consequently, may cause material effect on our business.

The Board has paid attention to the Group's policies and practices on compliance with all significant legal and regulatory requirements essential to its business and would seek professional advice from external legal advisers and consultants, if considered necessary, to ensure that transactions to be performed by the Group are in compliance with applicable environmental policies, laws and regulations. During the period under review, as far as the Board is aware, the Group has complied in all material respects with the laws or regulations that have a significant impact on its operations.

遵守法律法規

本集團業務的許多方面均受法律法規的 約束,包括但不限於中國和世界其他國 家的商品和服務的銷售、商品説明、知 識產權、產品安全、食品安全、數據隱 私、保險、應課税商品、產品生態責 任、電信和廣播、競爭、上市和披露、 公司治理等方面。儘管我們積極確保合 規經營並尋求獲得一流的獨立法律服務 以確保合規方面達至最高標準,但任何 不遵守法律法規的行為都可能引致法律 訴訟並面臨責任和制裁。在任何情況 下,應對投訴、調查或法律程序,無論 其結果如何,都可能既費錢又費時,並 可能分散管理層的精力。更重要的是, 我們業務的長期可持續發展能力在很大 程度上取決於穩定和平衡的監管環境。 有關當局對政策或監管做法的意外變化 可能迫使我們改變業務戰略和做法,因 而可能對我們的業務造成重大影響。

董事會關注本集團在遵守對其業務至關 重要的所有重大法律及監管規定方面的 政策及常規,並會在認為有需要時尋求 外部法律顧問及顧問的專業意見,以確 保本集團將進行的交易遵守適用的環境 政策、法律和法規。於回顧期內,就董 事會所知,本集團在所有重大方面均已 遵守對其經營產生重大影響的法律或法 規。

FINANCIAL REVIEW

Results of operations

The Group recorded a turnover of approximately HK\$162,530,000 for the year ended 31 March 2023, representing a decrease by approximately 49.8% as compared to the turnover of approximately HK\$323,634,000 for last year. The overall decrease in turnover was mainly attributable to the extreme market conditions caused by the continued and prolonged outbreak of the Covid-19 pandemic. Administrative and other operating expenses decreased to approximately HK\$46,198,000 compared with approximately HK\$53,417,000 of the previous corresponding year, representing decrease of approximately 13.5%, mainly resulted from the decrease in research and development expenses on the development of a programmatic intelligent advertising and programmatic content operation system. A loss from changes in fair value less costs to sell of biological assets of approximately HK\$2,445,000 was recognised for the year. A provision of approximately HK\$6,983,000 for impairment loss in respect of trade receivables was recognised for the year. Loss attributable to owners of the Company for the year ended 31 March 2023 was approximately HK\$58,164,000, which was approximately 41.6% higher than the loss attributable to owners of the Company incurred for last year of approximately HK\$41,082,000.

Liquidity and financial resources

The Group's operations and investments were financed principally by cash generated from its business operations, borrowings and shares issued. As at 31 March 2023, cash and bank deposits of the Group amounted to approximately HK\$10,882,000 representing a decrease of approximately 43.7% comparing with the cash and bank deposits of approximately HK\$19,339,000 as at 31 March 2022. The Group's net current liabilities, which comprised properties held for sale, inventories, biological assets, trade and other receivables, cash and bank deposits, trade and other payables, contract liabilities, lease liabilities, amount due to a shareholder, amounts due to directors, related companies, and amounts due to non-controlling interest, amounted to approximately HK\$60,840,000 as at 31 March 2023 (2022: HK\$5,679,000).

The Group's gearing ratio, which was defined as the ratio of debt to equity, was approximately 475% as at 31 March 2023 (2022: 128%).

財務回顧 經營業務業績

截至二零二三年三月三十一日止年度, 本集團錄得營業額約162.530.000港元, 較去年營業額約323.634.000港元減少 約49.8%。營業額整體減少主要歸因於 持續漫長的Covid-19疫情下的極端市 况。行政及其他經營開支較去年同期約 53,417,000港元減少至約46,198,000港 元,增加約13.5%,主要由於研發開支 因開發程序化智能廣告及程序化內容運 營系統而減少。生物資產之公平值變動 減出售成本所得虧損約2,445,000港元已 於本年度確認。本年度就應收賬款確認 了約6.983.000港元的減值虧損撥備。截 至二零二三年三月三十一日止年度,本 公司擁有人應佔虧損約為58.164.000港 元,較上年產生之本公司擁有人應佔虧 損約41.082.000港元增加約41.6%。

流動資金及財務資源

本集團之營運及投資主要由其業務營 運、借貸及已發行股份產生之現金撥付 資金。本集團於二零二三年三月三十一 日之現金及銀行存款約為10,882,000港 元,較於二零二二年三月三十一日之現 金及銀行存款約19,339,000港元減少約 43.7%。本集團於二零二三年三月三十一 日之流動負債淨值(包括持作出售物業、 存貨、生物資產、應收賬款及其他應收 款項、現金及銀行存款、應付賬款及其 他應付款項、應付董事及關連公司款項 及應付非控股權益款項)約為60,840,000 港元(二零二二年:5,679,000港元)。

本集團於二零二三年三月三十一日之資 本負債比率乃界定為負債對權益比率, 約為475%(二零二二年:128%)。

Capital structure

Details of the movements in the Company's share capital are set out in note 29 to the consolidated financial statements.

Fund raising activity

On 23 June 2023, the Company entered into eight separate subscription agreements with eight subscribers, pursuant to which the Company has conditionally agreed to issue, and the Subscribers have conditionally agreed to subscribe for, the convertible notes with aggregate principal amount of HK\$31,950,000. Further details were disclosed in the Company's announcements dated 25, 26 and 28 June 2023.

Treasury policies

The Group adopted a conservative treasury policy to maintain cash necessary to meet anticipated expenditures plus a reasonable cushion for emergencies. Almost all bank deposits are being kept in Hong Kong dollars, or in the local currencies of the operating subsidiaries to minimise exposure to foreign exchange risk. Any excess cash would be invested in liquid income-producing instruments which should be managed by a qualified investment manager or operated in accordance with advice provided by a qualified investment manager or decision of an investment committee, if formed, comprising at least one executive director, at least one independent nonexecutive director and at least one individual who must possess appropriate professional qualifications and/or financial and investment expertise and experience.

Most of the trading transactions, assets and liabilities of the Group were currently denominated in Hong Kong dollars, United States Dollars and Renminbi. The Group did not experience any material difficulties on its operations or liquidity as a result of fluctuation in currency exchange rates during the year under review. As at 31 March 2023, the Group had no foreign exchange contracts, interest of currency swaps or other financial derivatives for hedging purpose.

The Group is closely monitoring the movement of the foreign currency rates and will consider hedging significant foreign currency exposure should the need arise.

股本結構

集資活動

於二零二三年六月二十三日,本公司與八 名認購人訂立八項獨立認購協議,據此, 本公司已有條件同意發行,而認購人已 有條件同意認購本金總額為31,950,000 港元的可換股票據。進一步詳情已於本 公司日期為二零二三年六月二十五日、 二十六日及二十八日的公告披露。

庫務政策

本集團採取審慎庫務政策,以維持所需 的現金,以應付預期開支及就緊急情況 提供合理緩衝。幾乎所有銀行存款均為 港元,或為經營附屬公司之當地貨幣, 務求將外匯風險減至最低。任何超額朝 金應投資於產生流動收入的工具。而 該 產應投資經理所提供的意見或投資, 員會(倘成立,則由至少一名執行董事、 至少一名獨立非執行董事及至少一名炎 須具備適當專業資格及/或財務及投資 專業知識及經驗的人士組成)的決定進行 操作。

本集團大部分貿易交易、資產及負債目 前均以港元、美元及人民幣計值。於回 顧年度內,本集團並無因貨幣匯率波動 而在營運或流動資金方面遭遇任何重大 困難。於二零二三年三月三十一日,本 集團概無任何外匯合同、利息或貨幣掉 期或其他用作對沖之財務衍生工具。

The board (the "Board") of directors (the "Directors") of Great World Company Holdings Ltd (the "Company") has been committed to maintaining a high standard of corporate governance within the Company and its subsidiaries (the "Group") in order to enhance the transparency in disclosure of material information. The Board considers such commitment is essential for internal management, financial management and protection of shareholders' interest and believes that maintaining a high standard of corporate governance benefits all shareholders, investors and the business of the Company as a whole. The Company has applied the principles in and complied with the requirements of the Corporate Governance Code ("CG Code") as set out in Appendix 15 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") throughout the year ended 31 March 2023 except for the following deviations:

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the required standard of dealings as set out in Rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct regarding the Directors' transactions in securities of the Company. Having made specific enquiry of all Directors, each of the Directors has confirmed that he/she has complied with the required standard of dealings as set out in the adopted code of conduct regarding Directors' securities transaction throughout the year ended 31 March 2023.

BOARD OF DIRECTORS

The Board is responsible for reviewing, evaluating and finalising the Company's strategies and policies, annual budgets, business plans and performance, and has full access to adequate, reliable and timely information on the Group so as to enable them to make a timely decision. The Board also has the collective responsibility for leadership and control of, and for promoting the success of, the Group by directing and supervising the Group's affairs.

One of the roles of the Board is to protect and enhance shareholders' interests. The Board acts with integrity and due care for the best interests of the Company and its shareholders. Leading the Group in a responsible and effective manner, the Board adopts terms of reference which detail its functions and responsibilities, including, but not limited to, ensuring competent management, approving objectives, strategies and business plans and monitoring integrity in the Company's conduct of affairs. The management is obliged to supply the Board with adequate information in a timely manner to enable the members to make informed decisions and to discharge their duties and responsibilities. Each Director has separate and independent access to the Group's senior management to acquire more information and to make further enquiries if necessary.

The Board is also responsible for performing the corporate governance duties of the Company. The duties of the Board on corporate governance functions include developing and reviewing the Group's policies and practices on corporate governance, reviewing and monitoring the training and continuous professional development of the Directors and senior management and reviewing the Group's compliance with the CG Code and disclosure in this Corporate Governance Report.

董事會

董事會負責審閲、評估及落實本公司策 略及政策、年度預算案、業務計劃及表 現,並可全面取得有關本集團之足夠而 可靠之最新資料,以便彼等作出適時決 策。董事會亦透過對本集團事務作出指 示及監督,並共同負擔領導及監控本集 團之責任,並促進本集團之成功。

董事會亦負責履行本公司之企業管治職 責。董事會之企業管治職責包括制定及 檢討本集團之企業管治政策及慣例,檢 討及監察董事及高級管理層成員之培訓 及持續專業發展,審查本集團之企業管 治守則合規情況及本企業管治報告內之 披露事項。

The Board currently comprises three executive Directors, namely Mr. Zhang Yanqiang, Mr. Gu Zhonghai and Mr. Zhao Xinyan, one non-executive Director, namely Ms. Ng Mui King, Joky (chairman of the Board), and three independent non-executive Directors, namely Mr. Chung Koon Yan, Ms. Zhao Yongmei and Mr. Jing Baoli.

Each Director has different professional and industrial experience, which enable them to make valuable and diversified advice and guidance to the Group's activities and development. Details of the background and qualifications of the Directors are set out on pages 6 to 8 of this annual report. The Company has received, from each of the independent non-executive Directors, an annual confirmation of his/her independence pursuant to Rule 5.09 of the GEM Listing Rules. The Company considers all of the independent non-executive Directors are independent.

Candidates to be nominated as directors of the Company are experienced, high calibre individuals. Under the Articles of Association of the Company, any Director appointed by the Board shall hold office until the first annual general meeting after his/her appointment and shall then be subject to re-election by the shareholders. Apart from this, every Director is subject to retirement by rotation in accordance with the Articles of Association of the Company.

During the year ended 31 March 2023, the Board held a total of 13 board meetings, inclusive of the quarterly regular meetings according to the CG Code. The attendance of each Director is set out on page 28.

CHAIRMAN

Ms. Ng Mui King, Joky was appointed as the Chairman of the Board in 2007. The primary role of the Chairman is to provide leadership for the Board and to ensure that the Board works effectively in the discharge of its responsibilities.

CHIEF EXECUTIVE OFFICER

The Company has not appointed a Chief Executive Officer and the day-to-day management of the Group's business is carried out by the senior management and monitored by the executive Directors. 董事會現行成員包括三名執行董事張炎 強先生、顧忠海先生及趙新衍先生,一 名非執行董事吳美琦女士(董事會主席) 以及三名獨立非執行董事鍾琯因先生、 趙咏梅女士及井寶利先生。

BOARD COMMITTEES

The Board has established three committees in accordance with the CG Code, namely the Audit Committee, the Remuneration Committee and the Nomination Committee. These committees are provided with sufficient resources to discharge their duties and are able to seek independent professional advice when appropriate and upon request. Details of these committees, including their compositions, major responsibilities and functions, and work performed during the year ended 31 March 2023 are set out below:

Audit Committee

The Audit Committee currently comprises three independent non-executive Directors, namely Mr. Chung Koon Yan (chairman of the Audit Committee), Ms. Zhao Yongmei and Mr. Jing Baoli. The Audit Committee meets with the Group's senior management regularly to review the effectiveness of the internal control systems and the quarterly, interim and annual reports of the Group.

The primary responsibilities of the Audit Committee are:

- making recommendation to the Board on the appointment, re-appointment and removal of the external auditor and to approve the remuneration and terms of engagement of the external auditor and any resignation and dismissal of that auditor;
- (ii) reviewing and monitoring the independence and objectivity of the external auditor and the effectiveness of the audit process in accordance with applicable standard;
- (iii) liaising with the Board, senior management and the auditors to monitor the integrity of financial statements, the quarterly, interim and annual reports in particular on accounting policies and practices and compliance with accounting standards, the GEM Listing Rules and other legal requirements in relation to financial reporting;
- (iv) reviewing the financial control, internal control and risk management system to ensure the management of the Company discharges its duty under an effective internal control system;
- (v) reviewing the report and management letter submitted by external auditor, and considering any findings of major investigations of internal control matters as delegated by the Board or on its own initiative and management's response; and

The primary responsibilities of the Remuneration Committee are:

- conducting regular review of the remuneration policy of Group's directors and senior management;
- making recommendations to the Board on the Company's policy and structure for all remuneration of Directors and senior management and on the establishment of a formal and transparent procedure for developing such remuneration policy;
- (iii) making recommendation to the Board on remuneration packages of the Directors;
- (iv) determining remuneration packages of senior management proposed by the Directors that will attract, motivate and retain the competent staff;
- (v) reviewing and approving performance-based remuneration by reference to corporate goals and objectives resolved by the Board from time to time;

- (b) identifying and nominating for approval of the Board suitably qualified candidates as additional Directors or to fill Board vacancies as they arise;
- (c) making recommendations to the Board with respect to the re-election by shareholders of any Director under the relevant provisions in the Company's articles of association;
- (d) assessing the independence of the candidates in the case of appointment and re-appointment of independent non-executive Directors having regard to relevant guidelines or requirements of the GEM Listing Rules in place from time to time; and
- (e) assessing the independence of independent non-executive Directors on an annual basis having regard to relevant guidelines or requirements of the GEM Listing Rules in place from time to time.

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board. Upon the review of the Board's composition taking into account the diversity policy, the Nomination Committee considers that the Board has maintained an appropriate mix and balance of age, ethnicity, skills, knowledge, experience and diversity of perspectives appropriate to the business requirements of the Company. The Nomination Committee will review the board diversity policy to ensure its effectiveness on a regular basis or as required.

The Company adopted a nomination policy which sets out the selection criteria in assessing the suitability of a proposed candidate as Director and procedure of appointing and re-appointing a Director. In assessing the suitability of a proposed candidate, the Nomination Committee would consider factors including but not limited to academic background, qualifications, relevant experiences in the industry, character and integrity of the candidate, whether the candidate can contribute to the diversity of the Board and the candidate's commitment in respect of available time and relevant interest. Suitable candidate can be nominated by any Director for the Nomination Committee's consideration. The Nomination Committee should evaluate the personal profile of the candidate based on the selection criteria as set out in the nomination policy and undertake adequate due diligence in respect of each proposed candidate. After comprehensive assessment, the Nomination Committee will then make recommendation to the Board for approval. The Nomination Committee will review the nomination policy and assess its effectiveness on a regular basis or as required.

DELEGATION BY THE BOARD

The Board is responsible for determining the overall strategy and corporate development and ensuring the business operations are properly monitored. The Board reserves the right to decide all policy matters of the Group and material transactions. The Board delegates the day-to-day operations to senior staff who are responsible for different aspects of the operations of the Group.

Directors' and Officers' Liabilities

The Company has arranged for appropriate insurance coverage in respect of legal action against the Directors in compliance with the CG Code. The insurance coverage is reviewed on an annual basis.

ACCOUNTABILITY AND AUDIT

The Board is responsible to ensure the preparation of the financial statements of the Company and the Group in accordance with the relevant statutory requirements and applicable accounting standards and to ensure the published consolidated financial statements should be issued in a timely manner and can provide a true and fair view of the business and financial information of the Group. In preparing the consolidated financial statements, the Board has adopted Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants and accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinances that are relevant to its operations.

The Board is not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Group's ability to continue as a going concern, the Board has prepared the consolidated financial statements on a going concern basis.

The responsibilities of the external auditors on financial reporting are set out in the Independent Auditors' Report on the Group's consolidated financial statements for the year ended 31 March 2023.

A set of measures has been formulated and implemented to tighten the control on cash flow. All payments should be properly checked and approved. Proper accounting and financial records shall be maintained in supporting financial budgets, periodic management accounts and reports.

Operation

With regard to the Group's businesses, different sets of principles and procedures have been set up for management teams of different operations to follow. Through the implementation of those principles and procedures, the operation process became more accountable, transparent and efficient.

Compliance

The Company has fully complied with the requirements of the GEM Listing Rules. Financial reports, announcements and circulars have been prepared and published in accordance with the requirements of the GEM Listing Rules.

During the year, the Company engaged an external independent consultant with professional staff in possession of relevant expertise (the "Independent Professional Firm") to perform internal audit function and to carry out an internal control review, which comprised, inter alia, enterprise risk assessment and review of the internal control system of the Group, including financial, operational and compliance controls. The review plan was approved by the Audit Committee and the Board. Based on the risk assessment and the review of the internal control system of the Group conducted by the Independent Professional Firm for the year, no significant risk and control deficiency was identified. The relevant assessment and review reports have been considered by the Audit Committee and the Board for assessing the effectiveness of the Risk Management and Internal Control Systems. The Audit Committee has also reviewed the adequacy of resources, staff qualifications and experience, training programmes and budget of the Accounting Function and the internal audit function performed by the Independent Professional Firm. The Board, through the reviews made by the Independent Professional Firm and the Audit Committee, concluded that the Risk Management and Internal Control Systems are effective and adequate for the Group as a whole.

Subject to compliance with applicable laws, rules, regulations and the articles of association of the Company, in deciding whether to propose a dividend payout, the Board will take into account, among other things, the Group's actual and expected financial performance, expected working capital requirements, capital expenditure requirements and future expansion plans, the retained earnings, distributable reserves and liquidity position of the Group, the general economic conditions and any other factors that the Board deems relevant.

The Board will review the dividend policy from time to time and there is no assurance that dividends will be paid in any particular amount for any given period.

SHAREHOLDERS' RIGHTS

Procedures for Shareholders to convene an extraordinary general meeting and to put forward proposals at Shareholders' meeting

Any one or more Shareholder(s) holding at the date of deposit of the requisition not less than one-twentieth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board by mail at Room 1202, 12/F., Great Eagle Centre, 23 Harbour Road, Wanchai, Hong Kong, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting on a date not more than 28 days after the date on which the notice convening the meeting is given, the requisitionist(s) him/herself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.



The summary of material ESG issues, which are covered in this report, are listed below:

A. ENVIRONMENTAL ASPECTS

Effect on Current Environmental Climate and Our Management

As an investment holding company of the Group, we aspire to be a sustainability advocate by leading the subsidiaries business as an example and setting ESG standards in our Group. In accordance with the global Glasgow Financial Alliance for the Net Zero, we have started to study and target the full decarbonization of our operations.

In order to achieve the target,

- 1. We identity ways to improve our overall energy efficiency and saving, for example, LED light tubes, turn off all unnecessary lights
- 2. We set ourselves a target to save at least 10% of paper consumption in two years, and we would generate a good result in next reporting year 2023-2024, for example, by way of double-sided printing and recycling papers
- 3. To focus on waste reduction, for example, to encourage employees to use re-usable cups in place of plastic or paper cups.

A. 環境方面 對當前環境氣候和我們管理的影響

作為本集團的投資控股公司,我們 立志成為可持續發展的倡導者,作 為標杆領導附屬公司業務發展,並 在本集團制定環境、社會及管治標 準。根據全球格拉斯哥淨零金融聯 盟,我們已開始研究並以我們業務 的全面脱碳為目標。

為實現該目標,

- 我們確定提高整體能源效率和 節能的方法,例如,LED燈管, 關閉所有不必要的燈光
- 我們為自身設定了一個目標, 在兩年內節省至少10%的紙張 消耗,我們將在二零二三年至 二零二四年的下一個報告年度 取得更好的成果。如雙面打印 和紙張回收
- 專注於減少廢物,如鼓勵員工 使用可重複使用的杯子代替塑 料杯或紙杯。

A1. Emissions

The Group is principally engaged in intelligent advertising and railroad media business, cultivation and sales of agricultural and forestry products business, trading (supply chain) business and property business and has been persistent in conducting its business in an environmentally responsible manner and takes measures to reduce the possible impact on the environment arising from its production and operating activities. We will closely monitor our greenhouse gas emissions and energy consumption and will stay abreast of environment related regulatory developments in the respective areas where the Group operates.

In terms of emissions, the Group's current business did not generate significant emissions, but the monitoring of emissions is still indispensable. Therefore, we will regularly arrange for the testing of air emissions.

Air Pollutant Emissions

The pollutants listed in the standard include particulate matter, sulfur oxides and nitrogen oxides. In addition, the cars we operate will also generate trace amounts of air emissions.

Hazardous Waste and Non-hazardous Waste

The Group did not generate any hazardous waste during the reporting year. Non-hazardous waste from the Group's operation was mainly office paper.

The total amount of non-hazardous waste generated by the Group during the reporting year was approximately 0.0587 tonnes, with an intensity of approximately 0.0005 tonnes per employee.

During the year, there was also no incident of noncompliance with local relevant environmental laws and regulations that have a significant impact on the Group relating to air and greenhouse gas, emissions, discharge into water and land, and generation of hazardous and non-hazardous waste.

A2. Use of Resources

To encourage effective utilization of resources, the Group's management will review and develop management policy regarding the use of energy and resources, which manages consumption of chemical pesticide, fertilizer, electricity, water and office paper.

Energy Consumption

The energy used in the Group's business operations is mainly consumption of purchased electricity. The Group consumed a total of 53,815.25 (2022: 35,517.38) kWh with an intensity of 827.93 (2022: 288.76) kWh per employee during the reporting year.

The increase in total consumption and intensity was due to the fact that all employees returned to work in office and number of employees of the Group was decreased.

Water Consumption

To enhance the efficiency of water consumption and reduce waste water, the Group adopted a drip irrigation system, which help to achieve water conservation by reducing evaporation and deep drainage. Apart from using the purchased water, we also use rain water in the planting operation.

There is no records in consumption of water in forestry planting during the reporting year, and no issue in sourcing water that is fit for purpose. Nevertheless, the Group reminds employees to practice water conservation in daily operations.

The Government has standard measures and regular engagement on the Group's forest in terms of fire prevention and pest control practices. The Group cooperated with local government to perform pest control spray and fire prevention measures.

Positive effect of our business to the environment

In Xinjiang, desertification issue made destruction to the environment. Our business, planting forest, is an effective way to prevent desertification and sandstorm, and bring significant benefit to the environment.

B. SOCIAL ASPECTS ON STAKEHOLDER, ENGAGEMENT

B1. Employment and Labour Practices

Employees are regarded as the greatest and valuable assets and core competitive advantage of the Group. The Group reviewed and updated our existing remuneration policies, e.g. whistleblowing policy, grievance, personal account dealing and antidiscrimination.

The recruitment and promotion of the Group are fair and open for all employees, and are not affected by age, sex, physical or mental health status, marital status, family status, race, skin colour, nationality, religion, political affiliation and sexual orientation and other factors. The Group has maintained proper systems to ensure equity and competitiveness of staff remuneration and recognition. Risk management is an important part of ensuring occupational safety. We can identify and assess occupational health and safety risks through identification of the source of danger, assessment of identified risks, and appropriate risk control measures.

In order to avoid accidents and ensure that all employees work in a safe manner, we implement established policies and guidelines for different working conditions and needs which stipulates clearly the safety procedures as well as emergency response plans. Those established policies and guidelines will be reviewed periodically and further improved to better protect our employees.

The management department of the Group's office has also conducted a comprehensive fire drill and emergency drill regularly. Through actual drills, employees' ability to escape and save themselves at the scene of the fire was enhanced, employees' use of fire-extinguishing tools was improved, and everything was done to reduce human and property losses.

For the year ended 31 March 2023, there was no breach of relevant laws and regulations relating to employee's health and safety. The Group received no prosecutions related to occupational health and safety. No work-related fatalities occurred between 2021 and 2023.

The Group attaches importance to developing and maintaining long-term relationships with our suppliers, looking forward to forming long-term partnerships with them. SHARE OPTIONS

2012 Share Option Scheme

The Company has adopted a new share option scheme at the annual general meeting of the Company held on 3 August 2012 (the "2012 Share Option Scheme"), which is valid and effective for a period of 10 years commencing on 3 August 2012, upon the termination of the share option scheme adopted at the annual general meeting of the Company held on 2 August 2002.

The 2012 Share Option Scheme enables the Company to grant options to selected persons to subscribe for shares in the Company as incentives or rewards for their contributions or potential contributions to the Group. The Board may, at its discretion, invite (i) any director or any employee of the Company, any of its subsidiaries or any invested entity; (ii) any holder of legal or beneficial title of any securities issued by any member of the Group or any invested entity; (iii) any business or joint venture partner, contractor, subcontractor, agent, sub-agent of the Group or any invested entity; (iv) any person or entity that provides research, development or other technological support or any advisory, consultancy, professional services to any member of the Group or any invested entity; and (v) any supplier of goods or services, customer or distributor of the Group or any invested entity, to take up options to subscribe for the shares in the Company for a consideration of HK\$10 per each lot of share options granted.

The option period shall not exceed 10 years from the date of grant of option. There is no minimum period for which an option must be held before it can be exercised. HK\$10 is payable on acceptance of an option within 28 days from the date of grant.

We draw attention to Note 3 in the consolidated financial statements, which indicates that the Group incurred a net loss of approximately HK\$67,030,000 for the year ended 31 March 2023 and, as of that date, the Group's current liabilities exceeded its current assets by approximately HK\$60,840,000. As stated in Note 3, these events or conditions, along with other matters as set forth in Note 3, indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matter described in the *Material Uncertainty Related to Going Concern* section, we have determined the matters described below to be the key audit matters to be communicated in our report.

Key audit matter

Net realisable value of properties held for sale

Refer to note 17 to the consolidated financial statements

At 31 March 2023, the Group has properties held for sale located in the People's Republic of China with the carrying amounts of approximately HK\$71,427,000.

The properties are stated at the lower of cost and net realisable value on an individual property basis. Net realisable value is estimated at the actual or estimated selling price less estimated costs to be incurred and the estimated costs necessary to make the sales. The determination of net realisable value with reference to the valuation performed by the independent qualified professional firm of valuers require management judgement.

How our audit addressed the key audit matter

Our audit procedures in relation to the management's determination of the valuation of properties held for sale including but not limited to:

- evaluating whether the development progress for each project was consistent with the development plan;
- evaluating the competency, capability and objectivity of the valuers;
- assessing the methodologies used and the appropriateness of the key assumptions based on our knowledge of the relevant industry and using our valuation experts;
- discussing with the independent external valuer and challenging the reasonableness of key assumptions based on our knowledge of the business and industry; and
- checking, on sampling basis, the accuracy and relevance of the input data used.

We found the carrying amounts of properties held for sale were supported by the available evidence.

1. GENERAL INFORMATION

Great World Company Holdings Ltd (the "Company") is incorporated in the Cayman Islands as an exempted company with limited liability and its shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The address of the Company's registered office is P.O. Box 309, Ugland House, Grand Cayman KY1-1104, Cayman Islands, British West Indies and its principal place of business is room 1202, 12/F, Great Eagle Centre, 23 Harbour Road, Wanchai, Hong Kong. Win Bless Limited ("Win bless") and Gold City Assets Holdings Ltd. ("Gold City") are the substantial shareholders of the Company. Win Bless is beneficially owned by Mr. Zhao Xinyan, an executive director of the Company, and Gold City is beneficial owned by Ms. Ng Mui King, Joky, a non-executive director of the Company.

The principal activity of the Company is investment holding. The principal activities of its subsidiaries (together with the Company, the "Group") are set out in note 39 to the consolidated financial statements.

The consolidated financial statements are presented in Hong Kong dollar ("HK\$"), which is the same as the functional currency of the Company and all values are rounded to the nearest thousand ("HK\$'000") except otherwise indicated.

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") and by the disclosure requirements of the Hong Kong Companies Ordinance.

Going Concern Assessment

The Group incurred a net loss of approximately HK\$67,030,000 (2022: HK\$49,409,000) for the year ended 31 March 2023 and, as of that date, the Group's net current liabilities exceeded its current assets by HK\$60,840,000 (2022: HK\$5,679,000).

The above events or conditions may cast significant doubt on the entity's ability to continue as a going concern and, therefore, the Group may be unable to realise its assets and discharge its liabilities in the normal course of business. The directors of the Company have given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial resources to continue as a going concern. Certain measures have been taken to mitigate the liquidity pressure and to improve the Group's financial position which include, but are not limited to, the following:

- (i) the Group will apply stringent cost control in administrative expenses and capital expenditures;
- substantial shareholders of the Company agreed to provide financial support for the continuing operation of the Group;
- (iii) the Group has obtained consent from the relevant lenders not to demand for immediate repayment of such payables;

 - (iv) the Group will issue convertible note with aggregate principal amount of HK\$31,950,000, which further details are disclosed in Note 43; and
 - (v) the Group has been taking active measures to collect trade and other receivables through various channels to improve operating cash flows and its financial position.

However, the appropriateness of the going concern basis of accounting is dependent on the assumption that (i) the management of the Group will be able to achieve its plans and measures as described above; (ii) the Group is able to obtain continuous external financial support from substantial shareholder; (iii) the Group will be able to improve its business operations; (iv) the Group will be able to complete the Subscription (as defined in Note 43); and (v) the Group is able to generate sufficient cash flow and implement exercises to control costs.

Should the Group be unable to operate as a going concern, adjustments would have to be made to reduce the carrying values of the Group's assets to their realisable values, to provide for financial liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in these consolidated financial statements.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are accounted for in accordance with HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

Profit or loss and each item of other comprehensive income are attributed to owners of the Company and to the non-controlling interests. When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

The Group is a principal and obtains control any of the following: (i) a good or another asset from the other party that the Group then transfers to the customer; (ii) a right to a service to be performed by the other party, which gives the Group the ability to direct that party to provide the service to the customer on the Group's behalf; (iii) a good or service from the other party that the Group then combines with other goods or services in providing the specified good or service to the customer. If control is unclear, when the Group is primarily obligated in a transaction, is subject to inventory risk, has latitude in establishing prices and selecting suppliers, or has several but not all of these indicators, the Group records revenues on a gross basis. Otherwise, the Group records the net amount earned as commissions from products sold or services provided.

The Group has evaluated the roles and responsibilities of the Group and the agents in rendering the relevant services and concluded that the Group has the primarily obligation in rendering the services and has the sole latitude in establishing prices. Accordingly, the Group records the revenue driven through agents on a gross basis, and the commissions paid to those agents are records as sale commission as included in selling and marketing expenses.

Bearer plants are a living plant that is used in the production or supply of agricultural produce and are expected to bear produce for more than one period, and have remote likelihood of being sold as agricultural produce, except for incidental scrap sales. Bearer plants are accounted for in the same way as self-constructed items of property, plant and equipment. Depreciation is provided for in respect of bearer plants when they are in the location and condition necessary to be capable of operating in the manner intended by management, which is the point of maturity of bearer plants. Bearer plants are measured at accumulated cost less any impairment before maturity. When the bearer plants are mature, they are measured at cost, less any subsequent accumulated depreciation and impairment, with changes recognised in profit or loss.

Bearer plant is immature until the produce can be commercially harvested.

Investment property

Investment property is property held to earn rentals and/or for capital appreciation.

Investment property is initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is measured at their fair values, adjusted to exclude any prepaid or accrued operating lease income.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a first-in, firstout method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

Biological assets

Biological assets consist of the growing produce before harvest on trees. Trees are bearer plants and are accounted for as property, plant and equipment (see above).

The growing produce on trees are growing crops of the Group on the cultivation bases. Biological assets are measured at fair value less costs to sell on initial recognition and at the end of each reporting period. The fair value of biological assets is determined based on the current market price with reference to the species, growing condition, cost incurred and expected yield of the crops.

The agricultural produce is initially measured at fair value less costs to sell at the time of harvest. The fair value of agricultural produce is determined based on market prices in the local market. The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

Offsetting a financial asset and a financial liability

A financial asset and a financial liability are offset and the net amount presented in the consolidated statement of financial position when, and only when, the Group currently has a legally enforceable right to set off the recognised amounts; and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Cash and cash equivalents

Cash and cash equivalents comprise cash at banks and on hand and demand deposits with banks and other financial institutions that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Nonmonetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is also recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Government grants

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they are become receivable. In the application of the Group's accounting policies, which are described in note 3 to the consolidated financial statements, the directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

(i) Fair value of biological assets

The biological assets are valued at fair value less costs to sell. The fair value is determined based on either the market-determined prices at the end of the reporting periods adjusted with reference to the species, age, growing condition and costs incurred to reflect differences in characteristic and/or stages of growth of biological assets. Any change in the estimates may affect the fair value of biological assets significantly. The independent external valuer and management review the assumptions and estimates periodically to identify any significant change in the fair value of biological assets.

As at 31 March 2023, the Group had biological assets of approximately HK\$28,934,000 (2022: HK\$34,808,000). Details of the fair value of biological assets are disclosed in notes 19 and 38 to the consolidated financial statements.

(ii) Estimated impairment of trade receivables

Trade receivables with significant balances and creditimpaired are assessed for ECL individually.

In addition, the Group uses practical expedient in estimating ECL on trade receivables which are not assessed individually using a provision matrix. The provision rates are based on aging of debtors and their industry as groupings of various debtors taking into consideration the Group's historical default rates and forward-looking information that is reasonable and supportable available without undue costs or effort. At the end of each reporting period, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in note 37 to the consolidated financial statements.

(iii) Net realisable value for properties held for sale In determining whether allowances should be made for the Group's properties held for sale, the Group considers the current market environment and the estimated market value less estimated costs to completion and estimated costs necessary to make the sale. An allowance is made if the estimated market value is less than the carrying amount. If the actual net realisable value on properties under development is less than expected as a result of change in market condition and/or significant variation in the budgeted development cost, may result in material provision for impairment loss.

(iv) Fair value of investment property

Investment property is stated at fair value based on the market values, being the estimated amount for which property could be exchanged on the date of valuation between a willing buyer and a willing seller in an arm's length transaction or the valuation performed by an independent valuer. In determining the fair value, the valuer has based on method of valuation which involves certain estimates and assumptions. In relying on the valuation report, the management has exercised their judgements and is satisfied that the method of valuation is reflective of the current market conditions. Should there be any changes in assumptions due to change of market conditions, the fair value of the investment property will be adjusted accordingly. The Group is exposed to a number of risks related to its plantations as follows:

(1) Regulatory and environmental risks

The Group is subject to laws and regulations in the jurisdiction in which it operates. The Group has established environmental policies and procedures aimed at compliance with local environmental and other laws. Management performs regular reviews to identify environmental risks and to ensure that the systems in place are adequate to manage those risks.

(2) Supply and demand risks

The Group is exposed to risks arising from fluctuations in the price and sales volume. Where possible the Group manages this risk by aligning its harvest volume to market supply and demand. Management performs regular industry trend analysis to ensure that the Group's pricing structure is in line with the market and to ensure that projected harvest volumes are consistent with the expected demand.

(3) Climate and other risks

The Group's plantations are exposed to the risk of damage from climatic changes, diseases, forest fires and other natural forces. The Group has extensive processes in place aimed to minimise those risks, including regular forest health inspections and industry pest and disease surveys.

(4) Price risk

The Group is exposed to price risks arising from changes in prices. The Group does not anticipate that the prices of populus alba var. pyramidalis and Chinese herbals will decline significantly in the foreseeable future. The Group reviews its outlook for Chinese herbals prices regularly in considering the need for active price risk management.

On 28 March 2022, the Company issued zero-coupon convertible note with principal amount of HK\$3,500,000 to Ms. Cheng Peng (the "Noteholder"), who is an independent third party. The convertible note is unsecured and repayable upon maturity which is on the third anniversary of the date of issue. The Noteholder entitled to convert the whole or any portion of the outstanding principal amount of convertible note into ordinary shares of the Company at the Noteholder's election at any time before the maturity at the HK\$1.00 (subject to adjustment as details in the Company's announcement dated 9 March 2022). The convertible note is denominated in HK\$ and are shown under non-current liabilities at 31 March 2022.

The Convertible Notes are compound financial instruments containing two components, liability and equity elements. The fair value of the liability component with carrying amount of HK\$3,006,000 at initial recognition was calculated using the discounted cash flows method at a market interest rate for the equivalent non-convertible note. The effective interest rate of the liability component on initial recognition is approximately 5.1%. The equity component with carrying amount of HK\$494,000 at initial recognition was stated at its fair value using the Binomial Tree Pricing Model and included under the heading "Convertible notes equity reserve".

32. RETIREMENT BENEFIT SCHEMES

The Group operates the Mandatory Provident Fund Scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution scheme, the assets of which are held in separate trustee-administered funds.

Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees' relevant income, with the employers' contributions subject to a cap of monthly relevant income of HK\$30,000 currently. The Group's contributions to the scheme are expensed as incurred and vested in accordance with the scheme's vesting scales. Where employees leave the scheme prior to the full vesting of the employer's contributions, the amount of forfeited contributions is used to reduce the contributions payable by the Group.

The employees employed by the Group's subsidiaries in the People's Republic of China (the "PRC") are members of state-managed retirement benefit schemes operated by the government of the PRC. The subsidiaries are required to contribute a specific percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefits schemes operated by the government of the PRC is to make the specified contributions under the schemes.

The conversion of RMB into other currencies is subject to the rules and regulations of foreign exchange control promulgated by the government of the PRC. The Group is not exposed to foreign exchange risk in respect of exchange fluctuation of HKD against RMB as the non-PRC subsidiaries of the Group does not have material balance in RMB.

Sensitivity analysis

The Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position.

At 31 March 2023, the Group has certain concentration of credit risk as 66% (2022: 62%) of the trade receivables of the Group were due from top five customers (2022: top five customer). The directors considered the credit risk is limited since the Group only trade with customer with an appropriate credit history and good reputation. The directors monitored the financial background and creditability of those debtors on an ongoing basis.

The credit risk of the Group mainly arises from trade and other receivables (excluding prepayments) and bank balances.
