INTRODUCTION

The purpose of this circular is to provide you with the information regarding the ordinary resolutions to be proposed, among other matters, relating to (i) the granting of the general mandates to the Board to issue and repurchase Shares; (ii) the re-election of Directors; and (iii) special resolution to the proposed amendments to the existing Memorandum and Articles of Association and the adoption of second amended and restated Memorandum and Articles of Association at the Annual General Meeting.

A notice convening the Annual General Meeting setting out the details of the ordinary and special resolutions to be proposed at the Annual General Meeting is set out on pages 101 to 106 of this circular.

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting of the Company held on 29 September 2022, the Directors were granted a general mandate to allot, issue and otherwise deal with Shares and a general mandate to purchase Shares on the Stock Exchange. These mandates will expire at the conclusion of the Annual General Meeting. At the Annual General Meeting, among other businesses, ordinary resolutions will be proposed to grant the Share Issue Mandate, the Repurchase Mandate and the Extension Mandate to the Directors.

The maximum number of Shares to be issued, allotted and otherwise dealt with pursuant to the Share Issue Mandate shall not exceed 20% of the Shares in issue at the date of passing of the ordinary resolution numbered 6 in the notice of Annual General Meeting.

The maximum number of Shares to be repurchased pursuant to the Repurchase Mandate shall not exceed 10% of the Shares in issue at the date of passing of the ordinary resolution numbered 7 in the notice of Annual General Meeting.

Each of the Share Issue Mandate, the Repurchase Mandate and the Extension Mandate will continue to be in force until the earliest of (i) the conclusion of the next annual general meeting of the Company following the Annual General Meeting; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable law of the Cayman Islands to be held; and (iii) the date on which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

Under Rule 13.08 of the GEM Listing Rules, the Company is required to give to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the ordinary resolution to grant to the Directors of the Repurchase Mandate. The explanatory statement required by the GEM Listing Rules is set out in Appendix I to this circular.

PROPOSED RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the Board consists of seven Directors, namely, Mr. Zhang Yanqiang, Mr. Gu Zhonghai, Mr. Zhao Xinyan, Ms. Ng Mui King, Joky, Mr. Chung Koon Yan, Ms. Zhao Yongmei and Mr. Jing Baoli.

In accordance with Article 117 of the Articles at each annual general meeting of the Company, one-third of the Directors for the time being (or if their number is not a multiple of three, then the number nearest to but not exceeding one-third) will retire from office by rotation provided that every Director shall be subject to retirement by rotation once every three years.

The Directors to retire will be those who have been the longest in office since their last re-election or appointment but as between persons who became or were last re-elected as Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by lot. A retiring Director shall be eligible for re-election.

Mr. Zhang Yanqiang, an executive director, and Mr. Chung Koon Yan, an independent non-executive director, will retire by rotation at the Annual General Meeting and, being eligible, offer themselves for re-election at the Annual General Meeting.

Biographies of the Directors proposed for re-election at the Annual General Meeting are set out in Appendix II to this circular.

PROPOSED ADOPTION OF THE NEW MEMORANDUM AND ARTICLES OF ASSOCIATION

On 1 January 2022, the Listing Rules were amended by, among others, adopting a uniform set of 14 core standards for shareholder protections for issuers regardless of their place of incorporation set out in Appendix 3 to the Listing Rules. Furthermore, the Company proposes to modernise and provide flexibility to the Company in relation to the conduct of general meetings. As such, the Board proposes to make certain amendments to the Memorandum and Articles of Association to (i) conform to the said core standards for shareholder protections; (ii) allow a general meeting to be held as an electronic meeting or a hybrid meeting; (iii) bring the Articles of Association in line with amendments made to the Listing Rules and applicable law in the Cayman Islands; and (iv) incorporate certain housekeeping changes. In view of the proposed amendments mentioned above, the Board also proposes to adopt the New Memorandum and Articles of Association.

The full text of the proposed New Memorandum and Articles of Association (marked-up against the Existing Memorandum and Articles of Association), which includes the details of the proposed amendments, is set out in Appendix III to this circular. A special resolution will be proposed at the Annual General Meeting to approve the proposed amendments to the Memorandum and Articles of Association and the proposed adoption of the New Memorandum and Articles of Association.

The Company's legal advisers as to Hong Kong laws and Cayman Island laws have respectively confirmed that the proposed amendments to the Memorandum and Articles of Association conform with the requirements of the Listing Rules and do not violate the applicable laws of the Cayman Islands. The Company also confirms that there is nothing unusual about the proposed amendments for a company listed in Hong Kong.

ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

Set out on pages 101 to 106 of this circular is a notice convening the Annual General Meeting at which, among other matters, ordinary resolutions will be proposed to grant the Share Issue Mandate, the Repurchase Mandate, the Extension Mandate to the Directors and to re-elect Directors, and special resolution will be proposed to amend Existing Memorandum and Articles of Association and adopt New Memorandum and Articles of Association.

In accordance with Rule 17.47(4) of the GEM Listing Rules, all votes of Shareholders at the Annual General Meeting will be taken by poll. An announcement of the results of the poll will be published after the Annual General Meeting in accordance with the requirements of the GEM Listing Rules.

A form of proxy for use at the Annual General Meeting is enclosed with this circular. RECOMMENDATION

This appendix contains the particulars that are required by the GEM Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed decision whether to vote for or against the resolution to be proposed at the Annual General Meeting in relation to the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the authorised share capital of the Company was HK\$300,000,000 comprising 3,000,000,000 Shares, of which 330,271,600 Shares are in issue.

Under the Repurchase Mandate, the number of Shares that the Company may repurchase shall not exceed 10% of the issued share capital of the Company as at the date of passing the relevant resolution at the Annual General Meeting.

Subject to the passing of the relevant ordinary resolution to approve the Repurchase Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 33,027,160 Shares during the period from the date of passing the relevant ordinary resolution up to the earliest of (i) the conclusion of the next annual general meeting of the Company following the Annual General Meeting; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable law of the Cayman Islands to be held; and (iii) the date on which such authority is revoked or varied by an ordinary resolution of Shareholders in a general meeting of the Company.

2. REASONS FOR THE REPURCHASE

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets of the Company and/or earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

3. FUNDING OF REPURCHASES

Pursuant to the Repurchase Mandate, any repurchase will be made out of funds which are legally available for the purpose in accordance with the Articles, the GEM Listing Rules and the applicable laws of the Cayman Islands.

As compared with the financial position of the Company as at 31 March 2023 (being the date to which the latest audited consolidated financial statements of the Group were made up), the Directors consider that there may be an adverse impact on the working capital and/or the gearing position of the Company in the event that the Repurchase Mandate were to be exercised in full. However, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing position of the Company.

4. UNDERTAKING OF DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the GEM Listing Rules and the applicable laws of the Cayman Islands.

5. EFFECT OF THE TAKEOVERS CODE

If a Shareholder's proportionate interest in the voting rights of the Company increases on the Company exercising its powers to repurchase Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition for the purposes of the Takeovers Code issued by the Securities and Futures Commission of Hong Kong. As a result, a Shareholder or a group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, may obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, according to the register of members kept by the Company and so far as is known to, or can be ascertained after reasonable enquiry by the Directors, the shareholding interests of the substantial Shareholders (as defined in the GEM Listing Rules) were as follows:

Mr. Zhang Yanqiang, ("**Mr. Zhang**"), aged 41, has been an executive director of the Company since 6 October 2014. He is the chairman of the nomination committee of the Company. From 12 November 2013 to 10 June 2021, Mr. Chung was an independent non-executive director of Asian Citrus Holdings Limited (stock code: 73), a company whose shares are listed on the MB and were admitted to trading on AIM (a market operated by the London Stock Exchange) in 2006 but which has been cancelled from trading on AIM since 29 May 2017.

Mr. Chung has entered into service contract with the Company and is entitled to a director fee of HK\$10,000 per month which is determined by the Remuneration Committee of the Company with regard to the duties and responsibilities concerned.

Mr. Chung has served as an Independent Non-Executive Director of the Company for more than nine years since 9 May 2008 and has provided his annual confirmation of independence to the Company pursuant to Rule 5.09 of the GEM Listing Rules. During his years of appointment, Mr. Chung has not been involved in the daily management of the Company nor in any relationship or circumstances which would interfere with his independent judgment, and he has demonstrated his ability to provide an independent, balanced and objective view to the Company's affairs. The Nomination Committee is of the view that Mr. Chung meets the independence criteria as set out in Rule 5.09 of the GEM Listing Rules and is regarded as independent in accordance with the terms of the criteria. Notwithstanding the length of his service, with his diversified background and professional experience, the Nomination Committee considers that the continuous appointment of Mr. Chung will be in the best interest to the Company and Shareholders as a whole as he will help to maintain the stability of the Board and has brought, and will continue to bring, valuable business experience and knowledge, professional expertise, deep and objective insights, as well as constructive and informed advices to the Board on its efficient and effective functioning and diversity. The Board, therefore, recommends Mr. Chung for re-election at the Annual General Meeting.

Save as disclosed in this circular and as at the Latest Practicable Date, Mr. Chung does not have any other relationship with any director, senior management or substantial or controlling shareholder of the Company or has any interest in the Shares within the meaning of Part XV of the SFO. As at the Latest Practicable Date, Mr. Chung does not hold any position with other members of the Group.
